## **NOTIFICATION OF DISCLOSABLE PECUNIARY INTERESTS**

### **EXPLANATORY NOTES**

You must complete this form and return it to the Council's Clerk within 28 days of your Council's adoption of a new Code.

If you subsequently disclose at a meeting an interest which you have not previously registered, you must notify the Clerk of the details of that interest within 28 days of that meeting

Any interests notified on the attached form or subsequently to the Clerk, will be included in the Register of Interests. A copy of the Register will be available for public inspection and the information in it will be published on the Parish/Town Council's web-site (if it has one) and on Wyre Council's website.

It is a criminal offence knowingly or recklessly to provide information that is false or misleading.

If you are in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid not registering something in error.

In this form, the following definitions apply:-

**"body in which the relevant person has a beneficial interest"** means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

**"director"** includes a member of the committee of management of an industrial and provident society;

**"land"** excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

**"relevant authority"** means the council of which you are a member;

**"relevant period"** means the period of 12 months ending with the day on which you notify a
